OHIO STATEHOUSE UPDATE

The 134th General Assembly (G.A.) officially began in January. House and Senate leadership teams have been elected, with much less drama than the last G.A. that included a vicious Speaker's battle. For the first half of this year, the legislature will focus on key budget bills that are introduced during the first few months of each new G.A.: the transportation budget, state operating budget, and the BWC and Industrial Commission budgets. (Note the capital bill is usually introduced during the G.A.'s second year.) Expect efforts to stimulate the economy, financially aid businesses impacted by the pandemic, limit the Ohio Dept. of Health's authority, and lessen bureaucracy and regulations. Committees began hearing legislation over the past two weeks. Several bills of interest to construction have already been introduced. Two of note have received hearings:

SB18 - Internal Revenue Code (Roegner, R-Hudson; Schaffer, R-Lancaster): To expressly incorporate changes in the Internal Revenue Code since March 27, 2020, into Ohio law and to declare an emergency. 2/10/2021 - passed by Senate; Vote 32-0, Emergency Clause 32-0. SB 18 is being fast-tracked and was amended last week with language to exempt the BWC dividends provided to employers from Ohio's CAT tax. The BWC received a legal opinion stating there is no statutory exclusion in Ohio Revised Code, and the dividends would be included in the definition of gross receipts and thus subjected to CAT. Employers will for the first time receive 1099s for their dividends. AGC supports exempting BWC dividends from Ohio's CAT tax.

<u>SB25 - Prohibit Defrauding Drug Tests</u> (Gavarone, R-Bowling Green): To enhance penalties for certain drug trafficking offenses committed in the vicinity of a substance addiction services provider, to prohibit defrauding an alcohol, drug, or urine screening test, and to name the act's provisions the Relapse Reduction Act. 2/9/2021 - Senate Judiciary, (Second Hearing). This bill was first introduced during the last G.A. at the request of CEA, which houses the Cleveland AGC, and is supported by AGC of Ohio. After receiving bipartisan support, it was lost in the last-minute chaos and shuffling of legislation during lame duck last year. The reintroduced bill has already received two hearings, and AGC last week submitted testimony in support of the prohibition and penalties for defrauding a drug test.

Other recently introduced bills of interest that are being monitored by AGC include: HB15 - Designate William Burgett Memorial Highway; HB68 – Private Contractor Payments; HB74 - FY 22-23 Transportation Budget; HB75 - FY22-23 Workers' Compensation Budget; HB76 - FY22-23 Industrial Commission Budget; HB88 - Require License for Commercial Roofing Contractors; HB91 - Authorize Certain Public-Private Initiatives; HB100 - Regards to Jail Construction/Maintenance; SB9 - Reduce Regulations; SB 13 - Shorten Period of Limitations-Contracts; SB 56 - Indemnity-Design Contracts.

CEA compiled an analysis of the discussed one-sided contract terms being incorporated into public contracts. VOLUNTEERS NEEDED TO TEST PORTIONS OF OFCC'S NEW VERSION OF OAKS-CI

Flexible Time Commitment; Remote Testing from Office/Home

AGC of Ohio has had meetings with OFCC over the past two years about problems with the current version of OAKS-CI. OFCC has been rewriting the program to create a "Version 2," and asked AGC to help find volunteers to perform external stakeholder testing on portions of it. The testing would take place remotely, and volunteers need only to commit the amount of time they have available over the course of two months.
